



## Annual Update FY 2013-2014

## **Achievements**

- Fusion crossed INR 300 Cr in cumulative loan disbursement since inception.
- Fusion has received NBFC-MFI certificate from the Reserve Bank of India.
- Fusion rating outlook has improved from BB (positive) to BBB (negative).
- Fusion has successfully forged debt relationship with 12 banks/ financial institutions and raised over INR 150 Cr (including securitisation) in FY 2013-14.
- Fusion successfully migrated to cloud based IT platform.
- As on 31st March 2014, PAR (> One Day) is 0.005 % and PAR (> 30 days) is 0.02 %.
