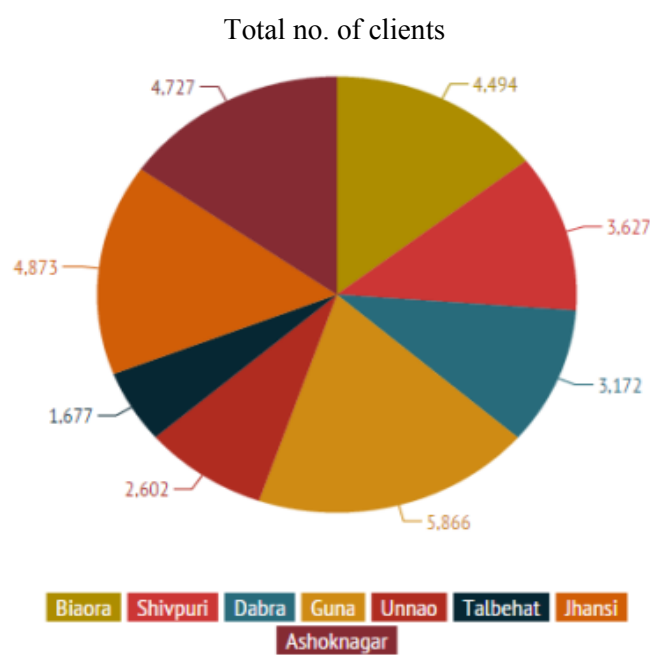

Appointment of a Grievance Redressal Officer for addressing client grievances

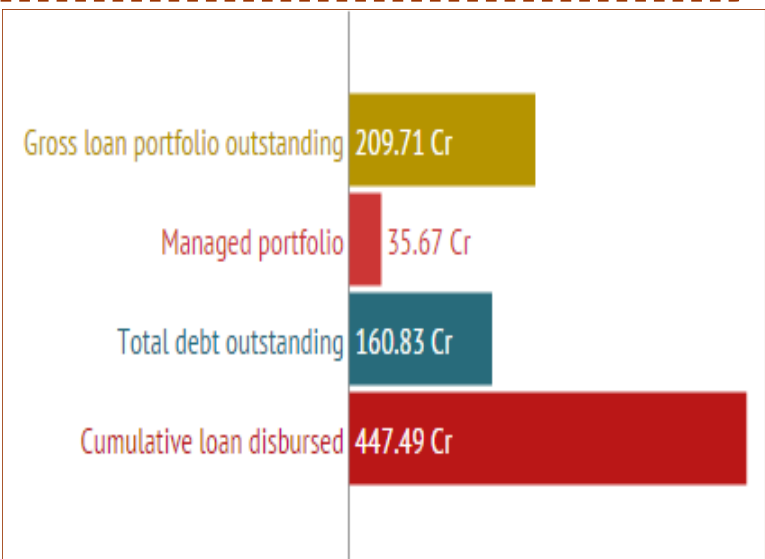
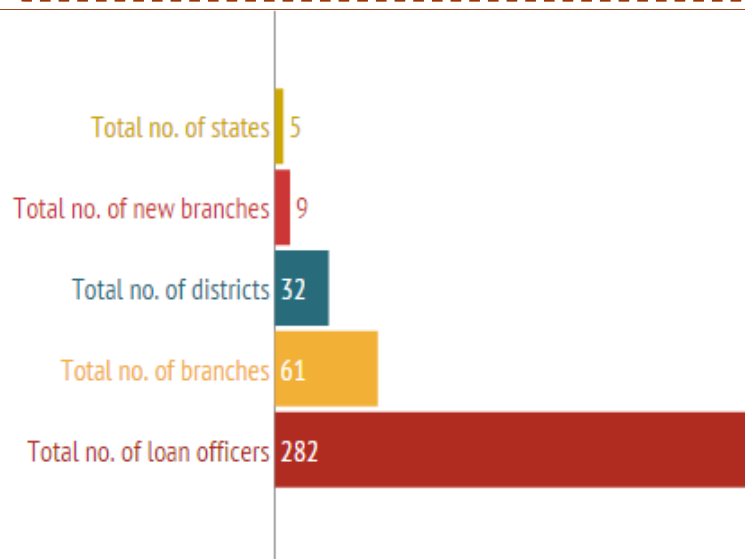
